# Westgold Win A Smeg Stand Mixer Competition Terms and Conditions

- 1. These terms and conditions relate to the Westgold Win A Smeg Stand Mixer Competition ("**Promotion**"). Information on how to enter and prizes forms part of, and entry into the Promotion is deemed to be acceptance of, these terms and conditions.
- 2. The promoter is Westland Dairy Company Limited ("Promoter").

## How to enter

- 10. Winners will be announced on the Westgold Instagram page on Tuesday 21st June 2022. The Promoter may also send an Instagram private message to the winner's Instagram account.
- 11. Accepting the prize: Following the Instagram announcement, winners will need to send an Instagram private message to the Westgold Instagram page

- with their contact details. This will enable the Promoter to supply their prize and will be deemed to be acceptance of the Prize.
